All emergency services from Cairns were involved and the debrief was an honest, candid affair. Lessons were learned that proved to be beneficial when it came to the real thing.


Feedback to us was that those involved in the fatal accident rescue scenario appreciated the importance of the exercise.




















We conduct two meetings a year – our next meeting will be November 2023.
